

  12. The Extension of affiliation has been granted in anticipation of approval of the Court, Aryabhata Knowledge University, Patna.
  13. The Extension of affiliation shall not take effect unless it is approved by the State Government.
  14. If any documents and statement will be found forged/fabricated in any stage, the affiliation letter will be withdrawn.
  15. Failing the above terms & conditions, this letter will be automatically treated as withdrawn. In such case no further correspondence shall be entertained.
